

#### Soar to New Heights Scholarship

The Centric Aviation Soar to New Heights Scholarships are offered to a Franklin and Gulf County High School sophomore, junior and seniors to help launch his or her flight training education. By making this scholarship available, Centric Aviation's goal is to foster and promote career opportunities in the aviation industry to local high school students.

### **Eligibility**

The Centric Aviation Soar to New Heights Scholarship applicant must:

- Be a high school sophomore, junior or senior student currently enrolled and in good standing in Franklin or Gulf County Florida School District or Homeschool Program
- Submit a short essay (no more than 500 words) to answer the following: What are your future goals? Why are you interested in this scholarship opportunity?
- Submit one letter of recommendation
- Complete and submit application before deadline May 5 2023

#### **Awards**

The Centric Aviation Soar to New Heights Scholarship, in the amount of \$1,000, is to be utilized for the sole purpose of flight training. Two \$1,000 scholarships will be awarded in 2023.

## **Application**
